Rental Terms and Conditions

1. This is a contract of rental only and not of sale.
2. All rentals are secondary to CCT/CYT productions.
3. A \$50 deposit will be required for all rentals. The deposit will be refunded if all terms and conditions are met.
4. The renter agrees to arrive at appointed time. The renter has **48** hours before appointment to change scheduled time if needed. Renter will be charged a **\$25 restocking fee** if you do not show up for appointed rental pick-up.
5. The undersigned renter agrees that all items rented are *as is* and will be returned in the same condition as was received. Any modifications must have prior approval of the CCT Rental Coordinator. Charges will be assessed for any unapproved modifications.
6. The renter is ultimately responsible for lost, stolen or damaged objects, and is obliged to repair, replace, or pay replacement costs.
7. In the event a renter fails to return said items at the agreed time, the renter agrees to pay a **late fee of thirty percent (30%)** of the weekly rental charge per day, per item.
8. The rental agent is not responsible for accidents or injuries related directly or indirectly to the use of the rented items.
9. The renter is responsible for transportation and securing of rentals during transport. Renter must verify that vehicle used for transport is large enough to accommodate rental items.

BACKDROP RENTAL SPECIAL INSTRUCTIONS:

CCT/CYT backdrops are in high demand. We do our best to satisfy the needs of our local CYT, national CYT and our rental clients. **All rentals are secondary to CCT/CYT productions.** In the event that a backdrop you have requested is needed for a CYT production, we will make our best attempt to give you a minimum of a week's notice to either pick a new backdrop from our catalog or make other arrangements.

***IMPORTANT:** As of November 1, 2005, CCT/CYT will require a **\$50 deposit** for all rentals. The deposit will be refunded at the return of the rental or put towards the remaining balance. Deposits will not be refunded if the terms and conditions of the contract are not met, this includes not showing up at your appointment time.
